Subject: Enhancement of Multilateral System (MLS) of Access and Benefit Sharing (ABS) submitted to 11th Governing Body of the ITPGRFA (Seed Treaty) and Implications on Farmers' Rights and National Sovereignty

Respected Sirs,

Bharat Beej Swaraj Manch (BBSM) is a national coalition of farmers and organisations working on structuring farmers rights into seed systems and agroecological framework. For us seeds and plants are life forms and we declare that the seeds and germplasm as part of national collective bio-cultural heritage.

We, the undersigned organizations and farmers, urge your immediate attention to the Draft Package of Measures submitted to 11th Governing Body of the ITPGRFA (Seed Treaty)—without consensus—by the Ad Hoc Open-ended Working Group to Enhance the Functioning of the MLS. The package fails to address existing problems and introduces proposals that risk deepening current flaws. Both the working group process and the package neglect Farmers' Rights and national sovereignty over seeds, in their attempt to make MLS attractive to the seed companies.

The package proposes measures that are heavily tilted towards commercial breeders and developed country interests and this indicate that the deliberations involved asymmetrical participation, and under representation. National positions are apparently not based on country level debates, but influenced by company lobbying groups that benefit from such positions. There were limited opportunities and spaces for domestic level discussion and debate.



The Problem of Non-Transparent and Unaccountable MLS

The lack of accountability and transparency in the operations of the MLS has fundamentally undermined its benefit-sharing objectives. While access to over 7.07 million accessions of plant genetic resources for food and agriculture (PGRFA) has been granted to more than 28,000 users, benefits have not flowed to provider countries or farmers. This failure is routinely excused by the claim that access to PGRFA itself is the benefit—an argument that disregards the Treaty's explicit mandate to share benefits arising from such access.

On the other hand, the new seed varieties and traits developed using our shared resources are being subjected to intellectual property rights without detection. These take place even without the knowledge of FAO, National Authorities and the farmers contributed seeds, such IPRs are being possible by the MLS terms and conditions. Various studies and events in the past have shown how these IPRs are being used to harass farmers, constricting and redefining their livelihoods.

A key reason for this failure is the absence of mechanisms to monitor user compliance with the Standard Material Transfer Agreement (SMTA) under which PGRFA are shared. Although Article 5 requires providers to notify the Governing Body of signed SMAs through the Secretariat, recipient-level information is withheld by the Secretariat. The Secretariat has disclosed only aggregate data, disabling public oversight and preventing provider countries and farmers from exercising vigilance, monitoring use and preventing biopiracy.

The CGIAR centres recently informed the Working Group that the use of MLS PGRFA is not detectable. Moreover, their earlier practice of disclosing SMTA data was halted at the request of the Treaty Secretariat. Despite this serious gap, the draft package proposes no corrective measures. Instead, it appears to legitimize this practice that contravenes Article 5 of the SMTA and Article 10 of the Treaty, by proposing to add three new additional confidentiality clauses into the SMTA.

Expansion of Coverage of MLS to ALL PGRFA

Further, the draft package proposes to expand the scope of MLS from 64 crops to all PGRFA, particularly to national collections. This raises serious concern, especially when framework of rights and the benefit-flows for the existing 64 crops are still hazy. It must be noted that the Treaty currently lacks a tracking mechanism to ensure that shared resources are used only in line with its stated purposes. Scaling up from 64 crops without demonstrating qualitative and tangible improvements in governance is a threat in itself to farmers rights and maintenance of ecological niche. The MLS was originally designed as a limited exception to national ABS systems, in line with the Convention on Biological Diversity (CBD), to promote food



security. The proposed expansion fundamentally alters this balance, contravening the Preamble, Articles 10 and 11 of Treaty.

No Safeguards to Prevent Infringement of Farmers Rights

The draft package also fails to include safeguards for universally accepted Farmers' Rights. It omits protections for the right to save, use, exchange, and sell farm-saved seed; to safeguard traditional knowledge associated with PGRFA and to informed-participation in sharing of benefits. Alarmingly, no proposals for effective safeguards were on the table. Several statements from farmers organisations and civil societies expressing concerns were not recorded on the meeting record, owing to so-called customary practice in Treaty meetings. This practice makes the promise of the Treaty on Farmers' Rights a mere rhetoric and it renders the rights framework under Article 9 infructuous, null and void.

The draft resolution simply says the proposed measures should not be interpreted as limiting the rights of the farmers. To farmers and peasants across the globe, many of whom are facing mounting pressure and legal threats from seed companies invoking intellectual property rights over seeds, this gesture rings hollow. There is no proposal to improve the process of taking prior informed consent from farmers or to develop vigilance mechanisms such that farmers can defend against their seeds being subject to intellectual property claims. The reality is stark: in the name of open science, seeds from farmers, indigenous peoples and local communities have been grabbed and global pools have been created — only to see those precious and invaluable seeds return to them in the form of proprietary, corporate-controlled, priced varieties. The entire process and the misdirected developments in the working group risk not only displacing traditional seed systems, but also pose serious ecological and health concerns.

All the promises of ensuring farmers rights became mere rhetoric and the entire process that did not include the discussion on safeguards rendered the declared and accepted rights framework infructuous, null and void. Effective safeguards are particularly essential to prevent privatization of traditional, pre-existing (prior art) varieties of farmers' seeds and their genetic DSI through fraudulent patenting and illicit claims of Intellectual Property Rights, infringing not only farmers' rights but also national sovereignty.

Biased Working Group Process

The Working Group has pursued the single, non-consensual and narrow objective: to make MLS more attractive to seed companies. In doing so, it has proposed measures inconsistent with the Treaty and the CBD, while disregarding its mandate from the Governing Body. Despite Resolution 7/2023 which invited the Co-Chairs to consider implications for Farmers' Rights in developing measures to enhance MLS, there was no document or agenda item in this regard in the working group. It did not propose improvisation of MLS to secure farmers



rights. In contrast, the Co-Chairs' document reveals strong emphasis has been given to courting seed companies. Because of this, we are compelled to argue that deliberations in the working group became painfully biased.

The proposed draft introduces measures in three-tiers of varying legality. First, to expand scope, it recommends amending the Treaty—creating binding obligations on States to share all PGRFA. Second, to increase user payments, it suggests only contractual measures, more unfortunately, with no oversight or accountability. There is very little possibility that either monetary or non-monetary benefit-sharing will significantly improve under the proposed measures. Third, for critical issues such as Farmers' Rights and benefit sharing from the use of Digital Sequence Information (DSI) on PGRFA, it offers only non-binding resolutions.

The proposed draft package of measures, addressing issues of access, benefit sharing and governance at varying levels of legality and importance, is undoubtedly biased and hence worthy of rejection. This structural discrepancy is not merely procedural. It raises serious concerns about the Working Group's integrity and the direction of MLS reform.

Our Demands:

1. Ensure Transparency and Accountability:

Immediately publish detailed information on PGRFA transfers under the current MLS and report to the 11th Governing Body the following:

- Identities of both providers and recipients;
- Specific PGRFA transferred, including accession numbers;
- Dates of transfer PGRFA accessions and receipt;
- Names of recipients who made monetary contributions and the corresponding PGRFA-derived products;
- Relevant GLIS links to the outcomes of research on such PGRFA accessions.

2. World Wide Open Consultation with Farmers Organisations:

Organize an online consultation with Farmers Organisations across the world on the proposed package and submit an information document to the Governing Body containing alternative text proposals to the draft package of measures, as proposed by Farmers Organisations.

3. Forward the present letter to all Contracting Parties and to 11th Session of Governing Body and support initiate a New Process:

Communicate the present letter to Contracting Parties, and to 11th Session of Governing Body and support initiate a new process to enhance the MLS without undermining benefit sharing opportunities under the CBD and national ABS frameworks, rejecting the present draft package. The new process must operate under clear terms of reference prioritizing:



- Protection of Farmers' Right at every stage of MLS Operations, by revisiting MLS objectives and process structure;
- Greater transparency and accountability of MLS and Treaty Secretariat;
- A balanced and mutually reinforcing approach between access and benefit-sharing. All commercial activity using MLS resources should result in monetary benefit sharing, not just seed sales.
- Measures to prevent biopiracy, including digital biopiracy, through unaccountable sharing and use of DSI/ GSD on PGRFA.
- Measure to ensure more effective participation of farmers' organizations, at all levels, national, regional and international.

4. Refrain from pressurizing developing country governments to conclude a bad deal that wash out their sovereignty over plant genetic resources.

We believe you will take these concerns into account as a matter of utmost importance and take necessary steps immediately.
